

## Instructions for Completing Application/Lineage Papers

### The Direct Descendants & Kin of David Crockett

1. Direct Descendants must submit a **COMPLETE application** and **include** documented proof.
2. Cousins are asked to submit a **COMPLETE application** but are not required to send proof. Proof from Cousins is welcome as it helps others research their own lineage.
3. Proof should be sent for each generation (or line on the form) which may include copies of birth, death, and marriage certificates, bible records, complete obituaries, wills, deeds, census records, old letters, etc. Every generation should link with proof to the next generation.
4. If you, the applicant, have been accepted through John or David Crockett in another historical organization that requires documented proof such as DAR, DRT and others, then a copy of their certificate is adequate proof and is sent with a **COMPLETE APPLICATION FORM**.
5. If another family member has already been accepted with a **COMPLETE APPLICATION &** documented proof and applicant wants to come in on that line, they must send proof up to that link.

EXAMPLE: John Doe is a member – son, Fred, wants to come in, so he must fill out a **Complete Application** and send a copy of his birth certificate linking him with his father. On bottom of the son's application a note should be added, **Refer to John Doe's applications for proof**.

6. Family tradition is not proof nor are undocumented family sheets done by another family member.

#### **ONLY COMPLETE APPLICATIONS WILL BE ACCEPTED.**

There are times when dates and places are unknown, especially in the earlier generations. Just leave the unknown dates & places blank. Mail all Completed Applications to
